

**Instructions and Important Dates for the  
2024 Edible Food Recovery Capacity Planning**

1. **Update Food Recovery Organization (FRO) List** – Cities shall verify and submit a complete list of FROs within the jurisdiction to the County by **August 31, 2023**.
2. **Update Tier One & Tier Two Commercial Edible Food Generator (EFG) List** – Cities shall compile a list of EFGs by business type, complete the **Jurisdiction Tier 1 and Tier 2 EFG Form** (See Excel sheet; ensure you select the business type from the drop-down menu), and submit to [FoodDROPLA@pw.lacounty.gov](mailto:FoodDROPLA@pw.lacounty.gov) by **April 30, 2024**.

3. **How to Identify Tier One & Tier Two Commercial EFGs** – To assist Cities updating the list of Tier 1 & Tier 2 Commercial EFGs in your jurisdiction, please utilize the available resources below when verifying your EFG information:
  - Los Angeles County Public Health Food Permit list (See Excel sheet)
  - Los Angeles County Public Health Restaurant and Market Inventory (See Excel sheet)
  - [CalRecycle Convenience Zone Data](#) (for Tier One Supermarkets)
  - CalRecycle Office of Local Assistance and Market Development [Contacts Search \(ca.gov\)](#) (for State Agency & Non-Local Entity lists)
  - Hauler Reports (customer list)
  - City Building Permits (to verify facility size for businesses such as Grocery Stores, Restaurants, State Agency Cafeterias, and etc.)

*Note: For the definition of each type of EFG and how to identify them, you can refer to CalReycle’s “How to Identify SB 1383 EFGs” guideline (See PDF file).*

4. For the category of “**Local Education Agencies**” – For the purpose of capacity planning at each facility site, cities should report all individual schools with an on-site food facility in each school district. You may refer to the “Public School Cafeterias” from Public Health’s food permit list.
